



## INVITATION TO TENDER

Botswana Ash (Pty) Ltd (Botash) is owned by the Government of the Republic of Botswana and Chlor Alkali Holdings (Pty) Ltd, part of the Bud Group of companies, a South African based company, at 50% shareholding each. Botash is located on the Sua Pan in North-Eastern Botswana at the west end of the A32 road and began operations in April 1991. It is the largest producer of natural sodium and related products in the region, currently producing several variants of soda ash and salt. The nameplate capacity of the plant is 300 000 tonnes of Soda Ash and 650 000 tonnes of Salt per annum. In the past, all activities of the company were undertaken on the Sua Pan – from production through to marketing, sales, and administration. Today Botash has increased its footprint with fully operating offices in South Africa, dealing primarily with sales and marketing of Botash products.
