SUPPLY AND DELIVERY OF PROTECTIVE CLOTHING TO NGWATO LANDBOARD

- SEALED TENDER OFFERS ARE INVITED for the procurement of protective clothing.
- The Procuring Entity is: Ngwato Landboard.
- Procurement Method is: Open Domestic Bidding.
- Tenderers must, in order to be considered for the award of the contract, be registered with the Public Procurement Regulatory Authority (PPRA) in the following categories:
Code: 211 – General Supplies, Sub-Code: 04 Uniform, Protective Clothing and General Clothing or
Code: 213 – General Manufacturers/Producers, Sub-Code: 09 – Garments
- The tender is reserved for citizens or citizen contractors as stated under section 76 (2) (d) of the Procurement Act. Contractors must be domiciled within Botswana in the Mahalapye, Palapye, Tutume, Bobirwa, Serowe, Districts. Locality of bidder must correspond and should be in one of the above Districts. Non-compliant bidders will not be considered.
- The tender is further reserved to targeted citizens or a category of businesses or sectors as follows:
Lot 1: This package is reserved for General Public.
Lot 2: This package is reserved for youth.
Lot 3: This package is reserved for women.
- The following preference schemes shall be applicable in this tender:
 - Economic Diversification Drive (EDD) will apply for the evaluation of this tender as per Presidential Directive CAB 34 (B) 2014.
 - Local Procurement Scheme (LPS).
- Documents may be collected during working hours between 0730 hours and 1245 hours and from 1345 hours to 1630 hours from Monday to Friday with effect from 3rd May, 2024.
- A non-refundable fee of P150.00 (One Hundred and Fifty Pula only) payable in cash is required on collection of the Tender Documents. 100% youth owned companies will be sold the tender at 50% of the selling price P75.00 (Seventy-Five Pula only) upon production of National Identity card(s), Share Certificate or Company Extract as per the Presidential Directive CAB 14 (B) 2015.

- Late tender offers will not be accepted.
- The Bid Submission Method is: One-Envelope Submission in which a tenderer's financial and technical offers are submitted together in one sealed envelope.
- One (1) original tender offer marked "Original" and two (2) duplicate copies of the original document marked "Copy" in one sealed envelope clearly marked: "Tender No. NLB/01/04/2024 — Supply and Delivery of Protective Clothing to Ngwato Landboard".
- The name and address of the bidder should be clearly marked on the back of the envelope.
