TENDER FOR THE PROCUREMENT OF REFRESHMENTS ON A FRAMEWORK CONTRACT BASIS FOR A PERIOD OF 24 MONTHS

- SEALED TENDER OFFERS ARE INVITED for the procurement of refreshments on a framework contract basis for a period of 24 months.
- The Procuring Entity is: Ministry of Lands and Water Affairs Corporate Services.
- Procurement Method is: Open Domestic Bidding.
- Tenderers who are domiciled in Botswana must, in order to be considered for award of the contract, be registered
 with the Public Procurement Regulatory Authority in the following category: Code: 207 General Supplies,
 Sub-Code: 01 General Food Supplies.
- The tender is reserved for citizens or citizen contractors as stated under section 76 (2) of the Public Procurement Act, 2021.
- Preference margins will be applied to qualifying bidders in line with the prescribed preference:
 Where applicable, the Presidential Directive on Economic Diversification Drive CAB 34 (B) of 2014 shall be applied in the evaluation of the tender. The Contractor (or supplier as the case may be) is required to abide by the undertakings given in the Guidelines on Economic Diversification Drive 2014 published by the Ministry of Trade and Industry. To benefit from EDD preferences, bidders must include certified copies of EDD certificate.
- This tender is reserved for youth operating within the jurisdiction of Greater Gaborone.

- The names and addresses of bidders should be clearly marked on the envelope.
