**ELECTRICAL WORKS CONTRACT FOR THE CONSTRUCTION OF (4NO. LA2 AND 1NO. LA3)  
STAFF HOUSES FOR RAMATLABAMA CLINIC**

- TENDER OFFERS ARE INVITED from eligible contractors for electrical works contract for the construction of Ramatlabama border Clinic staff houses.
- All applicable preference and reservation margins shall apply as outlined in the Economic Diversification Drive guidelines, Citizen Economic Empowerment Policy (CEEP) and Local Procurement scheme where appropriate, in the evaluation of this tender.
- The Procuring Entity is: Corporate Services, Ministry of Health, Gaborone. This is an Open Domestic Bidding Procurement Method and Least Cost Selection method will be used to evaluate.
- Tenderers who are domiciled in Botswana must, in order to be considered for award of the contract, be 100% citizen owned and registered with the Public Procurement Regulatory Authority in the following category: Code: 02 – Electrical Engineering Works and Maintenance, Sub-Code: 01 – Electrical Installations, Grade: B.
- The physical address for collection of Tender Documents is: Ministry of Health, Headquarters, (Government Enclave), Office No. 5A31. Tender Documents may be collected during working hours between 0800 hours and 1600 hours with effect from 23rd September, 2024.
- A non-refundable fee of P150.00 (One Hundred and Fifty Pula only) payable in cash or Point of Sale only, can be made at Ministry of Health, Headquarters, Accounts Office No. 4B8, prior to collection of the Tender Documents. Tender Documents are to be collected between 0730 hours and 1245 hours and from 1345 hours to 1530 hours during working days. All youth persons of age group 18 to 35 will purchase the Tender Document at half price; P75.00 (Seventy-Five Pula only) upon producing valid copies of *omang* and shareholder certificate as proof of company ownership (should own at least 51% of shares).
- A One-Envelope Procedure would be followed and bids shall be submitted in the manner below. Tender submissions shall be in a sealed envelope clearly labelled: “Tender No. POU/MOH/HSM/SUP/0143/29082024 — Electrical Works Contract for the Construction of (4No. LA2 and 1No. LA3) Staff Houses for Ramatlabama Clinic”.
