- The Procuring Entity is: Corporate Services.
- Procurement Method is: Open Domestic Bidding.
- Tenderers who are domiciled in Botswana must, in order to be considered for the award of the contract, be registered with the Public Procurement Regulatory Authority in the following categories: Code: 203 Electronic and ICT Supplies, Sub-Code: 01 Electronic Equipment, Spares and Accessories (including ICT, Photographic and Others).
- The tender is reserved for citizens or citizen contractors as stated under section 76 (2) (d) of the Public Procurement Act. Contractors must be domiciled within Greater Gaborone jurisdiction. Note: PPRA and CIPA locality of bidder must correspond and should be Greater Gaborone; non-compliant bidders will not be considered.
- The tender is further reserved to targeted citizens or a category of businesses or sectors as follows:
 - Package 1: This package is reserved for women operating within the jurisdiction of Greater Gaborone.
 - Package 2: This package is reserved for youth operating within the jurisdiction of Greater Gaborone.
- Prescribed Reservation or Preference Schemes shall be applicable in this tender.
 - Directive on the Economic Diversification Drive (EDD), Presidential Directive CAB 34 (B) 2014 and will be applied in this tender as per the applicable EDD.
 - The Presidential Directive CAB 34 (B) 2014 on New EDD, requires tenderers to purchase all their products from locally based manufacturers and service providers, provided that the goods and services are locally available, competitively priced and meet tender specifications in terms of quality and standard as certified or recognized by Botswana Bureau of Standards (BOBS) or other recognized certifying bodies.
 - To benefit from EDD preferences, bidders must include certified copies of "EDD certificate".
- The physical address for collection of Tender Documents is: Ministry of Lands and Water Affairs, AKD House, Main Mall, First Floor, East Wing, Office No. 125, Materials Management.
 Tender Documents may be collected during working hours between 0730 hours and 1245 hours and from 1345 hours to 1630 hours with effect from 4th December, 2023.
- A non-refundable fee of P250.00 (Two Hundred and Fifty Pula only) payable in cash or Point of Sale (POS) in favour of the Government of Botswana is required on collection of the Tender Documents. Youth owned companies shall pay P125.00 (One Hundred and Twenty-Five Pula only) to get the Tender Document upon producing a valid *omang* card.
