Fee: A non-refundable deposit of P150.00 (One Hundred and Fifty Pula only) in cash must be paid to Treasury Department, Revenue Office, Ghanzi-East Sub-District Council prior to collection of the Tender Document. (Youth to pay 50% of the payable amount, that is, P125.00 (One Hundred and Twenty-Five Pula only)). Produce a letter from the Ministry of Youth Empowerment, Sport and Culture Development confirming that the company is youth owned.

Delivery: Bidders must submit one (1) original and two (2) copies clearly marked as such enclosed in one single envelope labeled: "Tender No. GDC/GE/AB/45/2019 - A Works Contract for Construction of Grootlagte Sales Bay at Grootlagte Community Garden in Grootlagte, Ghanzi-East Sub-District". Tender offers should be delivered to the LAPAD Office at Ipelegeng Compound, behind Council Chambers. The closing date and time for receipt of tender offers is 10th February 2021 at 09:00. Tender offers shall be opened immediately thereafter, in LAPAD Office, behind Council Chambers. Tender offers received after 09:00 on the closing date, telegraphic, faxed, or emailed submissions will not be accepted.

Requirements : 100% citizen local contractors. The Procurement Method is Restricted Domestic Bidding. Bidders shall, in order to be considered for award of the contract, be 100% citizen contractors registered with Ghanzi District Council Contractor's Database and the Public Procurement and Asset Disposal Board (PPADB) under Code: 01 - Building Construction Works and Maintenance, Sub-Code: 01 - Building Construction, Grade: OC. The Pre-Tender Estimate for the works is P500,000.00. (This is for guidance only; bidders

may quote any amount but the award will be to the lowest compliant/reasonable bidder). The Presidential Directive CAB II (A) on Economic Diversification Drive (EDD) shall apply to this tender. 15% Price Preferential Treatment for companies owned by youth, women, and people with a disability shall apply to this tender. The Local Authorities Procurement and Asset Disposal Act, 2008, Conditions of Tender apply to this procurement, for which all the applicable Tender Data is contained in the Tender Documents.
