Fee: Tender Documents can only be collected on payment of a non-refundable fee of P250.00 (Two Hundred and Fifty Pula only) payable in cash to Ngwaketse Land Board, Revenue Office. Youth owned companies will be charged half of the non-refundable fee for the collection of the Tender Document. The companies should bring Form 2/8/13/14 from CIPA and IDs as proof of ownership upon purchase of the Tender Document. Youth in this regard shall be persons within the age of 18 - 35 years

Delivery: Method of Submission: One Stage Two-Envelope Method shall be used where a bid is submitted in an outer sealed envelope, containing two separately sealed and labeled envelopes marked and containing technical and financial proposals which are opened on different dates, in separate bid openings. opening. Telegraphic, telex, telephonic, and emailed tender offers will not be considered.

Requirements: Wholly owned citizens companies registered with the Public Procurement and Asset Disposal Board (PPADB) Code: 100 - Security Services, Sub-Code: 01 - Guard Services. The tender is reserved for companies wholly owned by citizens of Botswana. Wholly owned- refers to companies whose shareholding is 100% owned by citizens. Evaluation Method: Least Cost Selection. Procurement method: Open Domestic Bidding.
