The Physical address should not have been changed in the past three months.



- A compulsory site visit and/ or pre tender meeting with representatives of the Procuring Entity will take place at Council Works Depot along Independence road opposite Environmental Health Department on 6th August 2024. Registration will start at 0800 hours and stop at 0900 hours. Thereafter bidders who registered will be taken to site. Contractors who did not register will not be allowed to participate in the site visit activities. Bidders should note that a person cannot represent more than one company.
- The closing date and time for receipt of sealed tender offers is at 0900 hours on the 13 August 2024
- Late tender offers shall NOT be accepted.
- The tender evaluation will follow: least cost selection works and supplies method
- The Bid Submission Method is: One (1) Envelope Submission Method in which a tenderer's financial and technical offers are submitted together in one sealed envelope.
- Submit one (1) original tender document marked "ORIGINAL" and 2 duplicate copies of the original document marked "COPY" in one sealed envelope clearly marked:
"Tender Reference No: SPTC/CMS/T18/2024
"A WORKS CONTRACT FOR THE PROCUREMENT OF PAVING WORKS AT LUMUMBA STREET." shall be delivered to Procurement Unit (Supplies Depot) Plot 8919, along Independence Road Adjacent to Botswana Power Corporation premises, Selebi Phikwe.
The name and address of the bidder should be clearly marked on the envelope.
