


### T1.1 Tender Notice

TENDER NO. MDC/AB/CONST/T12/2024

#### A WORKS CONTRACT FOR CONSTRUCTION OF UPGRADING BONWAPITSE CLINIC

- The Procuring Department is ARCHITECTURE AND BUILDING SERVICES, MAHALAPYE DISTRICT COUNCIL.
- Tender offers are invited from from 100% citizen bidders domiciled in Shoshong Constituency for – **Works Contract for Construction of Upgrading Bonwapitse Clinic**. The procurement method is Restricted Bidding Method. The project estimate is P 540,000.00  
  
Tender is reserved to local bidders within Shoshong Constituency.
- Only tenders accompanied with a valid tax clearance certificate number and pin number (**this will be verified online**), Valid Copies of Omang for Company Director/s and PPRA Registration for Code 01(**Building Construction Works and Maintenance**), Sub Code 01(**Building Construction**), Grade OC (**registration will be verified online**) shall be considered for award of the contract.
- Local Procurement Scheme shall apply (up to 15% cumulative preference will be applied to the target group) bidders who qualify under this scheme are required to submit copies of Omang for employees (at least 60% will benefit under employment), certificate of disability to benefit under people with disability and Omang for youth and woman. (Only 100% companies owned by the target group will benefit under youth, woman and people with disability).
- Tender Documents will be available for purchase from 09<sup>th</sup> April 2024 and can be obtained from the **Architecture & Building Services Department, office no.C4A, Rural Administration Centre (RAC), Mahalapye** during working hours (i.e., from 07:30hrs to 12:45hrs and from 13:45hrs to 15:30hrs) on weekdays upon payment of a non-refundable fee of P150.00 (cash) at the Council Revenue office (Office No. 15). The receipt will be required on collection of the tender document. Note that Youth shall be required to pay a non-refundable fee of P75.00; this is in line with Presidential directive CAB 14 (B) 2015. Omang and Directors form that is form 2(b) and 2(c) shall be required as proof at Point of Sale.
- A bidder will only benefit once from projects for the financial year 2023/2024. Bidders who have on-going projects with Mahalapye District Council shall not be considered.
- An Entity and/or its Representatives such as Beneficial Owners, Partners / Directors/ Shareholders /Administrators for the Company/Partnership/ Society/Joint Venture/ Private Foundation/Statutory Body should not submit multiple bids for tenders under financial year 2023/2024, through any other registered company or other entity.
- Any enquires relating to issues in the Tender Documents shall be addressed to the Council Secretary, Mahalapye District Council, Private Bag 002, Mahalapye. Tel No. 471-8621/8643, Fax No. 4921-541. All enquiries shall be in writing and are to be submitted not later than 5 days before the tender closing date.
- Completed Tender offers must be clearly marked: “TENDER NO. MDC/AB/CONST/T12/2024 ‘A WORKS CONTRACT FOR CONSTRUCTION OF UPGRADING BONWAPITSE CLINIC’ and addressed to COUNCIL SECRETARY, MAHALAPYE DISTRICT COUNCIL, PRIVATE BAG 002, MAHALAPYE and shall be registered and hand delivered to the Procurement office, Office No. 60, Rural Administration Centre, MAHALAPYE DISTRICT COUNCIL, MAHALAPYE Bidders must submit one (1) original tender document marked ORIGINAL and, two (2) copies of the original each marked COPY clearly marked in one sealed envelope. The closing time for receipt of tender offers is 09:00 hours on 23<sup>rd</sup> April 2024. Late tenders and tenders sent by telephone, telex, telegraph, facsimile or email shall not be accepted.
- Tender opening shall be done immediately after closing at Conference Centre, Rural Administration Centre, MAHALAPYE DISTRICT COUNCIL, MAHALAPYE in the presence of bidders who wish to attend at their own expenses. Late tenders and tenders sent by telephone, telex, telegraph, facsimile or email shall not be accepted

- **A single envelope or package submission, in which a tender document containing the financial and technical officer of a bidder is submitted together in one sealed envelope or packaging (PPA Regulation 49).(a)**

- The Public Procurement Regulatory Authority Standardised Conditions of Tender for Works shall apply to this procurement, for which all the applicable Tender Data is contained in the tender documents.

- The bidders shall bear all costs associated with the preparation and submission of the tender and the Mahalapye District Council hereinafter will under no circumstances be responsible or liable for these costs, regardless of the conduct or outcome of the tender process.
