**A WORKS CONTRACT FOR CONSTRUCTION OF STORMWATER DRAINAGE
AT OLD MALL IN TLOKWENG VILLAGE**

- SEALED TENDER OFFERS ARE INVITED for the provisions a works contract for construction of storm water drainage at old mall in Tlokweng Village.
- The Procuring Entity is: Tlokweng District Council.
- Procurement Method is: Restricted Domestic Bidding to companies domiciled in Tlokweng as per CIPA Registration.
- Tenderers must, in order to be considered for award of the contract be, registered with the Public Procurement Regulatory Authority (PPRA) in the following categories: Code: 03 – Civil Engineering Sub-Code: 01 – Construction (Roads, Infrastructure, Airfields) and Sub-Code: 05 – Bridges, Grade: OC.
- This tender is opened to bidders who are domiciled in Tlokweng (as per CIPA Registration) and are 100% citizen owned contractors.
- The Directive Cab 19 (B) 2013: Local Procurement Scheme shall apply in this tender. Local Procurement Preferential Treatment is applicable to empower the youth, people with disabilities, women, and employment.
- Tenderers to purchase all their products from 100% citizen locally based manufacturers and service providers, provided that the goods and services are locally available, competitively priced and meet tender specifications in terms of quality standard as certified or recognized by Botswana Bureau of Standards (BOBS) or other recognized certifying bodies.
- The physical address for collection of Tender Documents is: Procurement Unit, Office No. 47, Tlokweng District Council, Rural Administration Centre, Plot No. 9909, along Mmaseroka Road, Tlokweng.
- Documents may be collected during working hours effective 24th April, 2024 between 0730 hours and 1245 hours and from 1345 hours to 1630 hours.
- A non-refundable amount of P150.00 (One Hundred and Fifty Pula only) payable in cash is required before collection of the Tender Documents. Payments should be made at Office No. 47, Tlokweng District Council, Rural Administration Centre, Plot No. 9909, along Mmaseroka Road, Tlokweng during working days between 0730 hours and 1245 hours and from 1345 hours to 1530 hours.
- Youth companies shall pay P75.00 (Seventy-Five Pula only) as per Presidential Directive CAB 14 (B) of 2015 upon proof of eligibility issued and certified by Ministry of Youth, Gender, Sport and Culture or share certificates or IDs for Directors and Shareholders.
- The pre-tender estimate is: P515,000.00 (inclusive of 14% VAT).
- Queries relating to the issuance of these documents may be addressed, in writing, not later than four (4) days before the tender closing date to: Principal Roads Engineer (T. Motsomatshekudu), Telephone No. 3695000, Fax No. 3928809.
- A compulsory pre-tender meeting with representatives of the Procuring Department will take place at Tlokweng District Council, Rural Administration Centre, Plot No. 9909, along Mmaseroka Road, Tlokweng on 30th April, 2024 where further instructions will be given.
- Attendance registration starts at 0800 hours and closes at 0900 hours.
- Tenderers who come later than the stated time will not be allowed to participate in the site visit activities which follows immediately after the pre-tender meeting.
- The Evaluation Method is: Least Cost Selection – Works Evaluation Method.
- The Bid Submission Method is: One-Envelope Submission in which a tenderer's financial and technical offers are submitted together in one sealed envelope.
- The closing time for receipt of tender offers is 0900 hours on 8th May, 2024. Opening of tender offers will be done immediately after closure of tenders on the same day in the Procurement Unit, Office No. 47, Tlokweng District Council, Rural Administration Centre, Plot No. 9909, along Mmaseroka Road in the presence of bidders wishing to attend.
- One (1) original Tender Document marked "Original" and two (2) copies of the original document marked "Copy" in one sealed envelope clearly marked: "Tender No. TDC/RDS/03/2024-25 — A Works Contract for Construction of Stormwater Drainage at Old Mall in Tlokweng" and addressed to: Council Secretary, Private Bag T05, Tlokweng and shall be delivered, registered and deposited into a Tender Box in Procurement Unit, Office No. 47, Tlokweng District Council, Rural Administration Centre, Plot No. 9909, along Mmaseroka Road, Tlokweng.
- The name and address of the bidder should be clearly marked on the envelope.
- Late tender offers shall not be accepted.

The Public Procurement Regulatory Authority's Standardised Conditions of Tender for Works shall apply to this procurement, for which all the applicable Tender Data is contained in the Tender Documents.

Notwithstanding anything in the foregoing, Tlokweng District Council is not bound to accept the lowest or any tender offer.
