- · Procurement Method is: Open Domestic Bidding
- Tenderers who are domiciled in Botswana must, in order to be considered for the award of the
 contract, be registered with the Public Procurement Regulatory Authority in the following categories:
 Code: 03 (Civil Engineering Works) Sub-code:01 (Construction-roads, infrastructure
 &airfields), Grade OC
- The tender is reserved for citizens or citizen contractors as stated under Section 76 (2) of the Public Procurement Act.
- Preference margins will be applied to qualifying bidders in line with the following scheme:

Local Procurement Presidential Scheme Directive No.19 B of 2013 (LPS), 15% price preferential treatment will be applied to companies owned by Youth, Women and People living with disability.

- Tenderers to purchase all their products from 100% Citizen locally based manufacturers and service providers, provided that the goods and services are locally available, competitively priced and meet tender specifications in terms of quality standard as certified or recognized by Botswana Bureau of Standards (BOBS) or other recognized certifying bodies.
